# Our Early Projects

## Roads & Bridges

On 6th October, 1976, five visionary men with extensive construction experience got together to found and steer Gamuda on an extraordinary and high growth journey, setting-up operations along Jalan Gopeng, in the mining town of Ipoh, Perak.

Gamuda's first project was the Bahau – Keratong Highway, and in the years to follow, Gamuda expanded its portfolio with various projects that proved pivotal to the Group's growth. From rural roads, bridges and buildings, the Group's expertise soon saw the construction of the Lumut Naval Harbour and Dockyard, Penang North Butterworth Container Terminal, and expanded further to include urban expressways and toll plazas, such as the Ayer Keroh - Senawang Toll and the Simpang Pulai - Gopeng Highway along the North South Expressway.

# Transformation into a Major Player in B.O.T. Projects

## Infrastructure Development

The rapidly growing Group shifted operations from Ipoh to the Klang-Valley in the late eighties. By now, the Group's engineering and construction capabilities were well-known, and it was not long before the Group was entrusted with projects that challenged the mindset of engineers. Malaysia was aspiring to be a developed nation with its Vision 2020, yet there were many areas that had to be improved. Realising these opportunities, Gamuda soon took on even more challenging projects, leading further to its listing on the Main Board of Bursa Malaysia (then known as the Kuala Lumpur Stock Exchange) in 1992. And the rest they say is history!

During the nineties, Gamuda has transformed into a major player in Build-Operate-Transfer (BOT) infrastructure projects and completed RM 10 Billion worth of contracts. During this period of growth, the Group has expanded its businesses from engineering and construction to the operations of infrastructure concessions, which include tolling of highways and supply of treated water.

Gamuda's expertise has left an indelible mark in Malaysia with projects like the Lebuhraya Damansara Puchong, Shah Alam Expressway, SPRINT Highway, the Sungai Selangor Water Supply Scheme Phase 3, and the innovative dual-use SMART tunnel. The group has the largest network of urban toll-roads in the Malaysia and is the nation's biggest water treatment operator.
